



# First Saturday Coloma Craft & Flea Market Vendor Registration Form 2012

The Coloma Area Historical Society (CAHS) will hold a Craft and Flea Market on the first Saturday of the month from May — October. Vendors are encouraged to sell: crafts, seasonal produce, baked goods, antiques and collectibles, rummage and other flea market items in an outdoor market in the Coloma Community Park.

Booths and tables may be set up in a tree-shaded area that is immediately adjacent to the historic CAHS Spalding General Store and Museum. **Registration for each vendor is \$10 in advance, 30 days prior to market date, or \$15 after the 30-day notice or on market day if space is available.**

**The First Saturday Coloma Craft & Flea Market will be held rain or shine, from 8 am to 3 pm.**

Vendors may begin set-up at 7 am and should bring their own tables, chairs, and booths. The vending space measures 10 x 12 feet. Parking is ample, restroom facilities nearby, and there is a large playground for the kids.
